# Welcome & Introductions

Facilitator Hannah Anderson called the meeting to order and thanked the participants for joining virtually via Zoom. Hannah prompted the Board members to introduce themselves. Non-board members were asked to introduce themselves as well, including the organization, agency, or interest they represented.

The Facilitator reviewed the agenda for the evening which proceeded as follows.

### Wildfire Crisis Report

Doug Ferrell was provided with updates on the statewide efforts on the fire crisis, from Steve Kimball of DNRC, to share with the board.

- Montana counties take the lead in updating County Wildfire Protection Plans (CWPP)
- Counties with CWPP can apply for grants that apply to priority areas
- Our Lincoln County has been a leader in pursuing projects and getting funding
- GNA program, administered by the state is growing to provide additional compacity for wildfire
  risk and forest health goals
- BLM and NRCS are increasing capacity to get more done on the ground in 2024

# <u>Proposals – (Tim Love) interlude in agenda</u>

Guest speaker Tim Love gave a brief overview from the Montana Forest Collaboration Network. Tim will be retiring later this year and many expressed appreciation for his leadership.

- Request for proposals for MFCN administered grants went out for the 7<sup>th</sup> of December
  - Proposals are due January 22<sup>nd</sup>
- Info from the Annual workshop has been posted on website if you did not come you can see the proceedings as annual report

### KFSC Workshop for 2024 Work Plan

Bob Castaneda presented the 2024 Work Plan to the board and opened the floor to discussion. He provided a brief explanation as to why the work plan is updated every year, and how the KFSC benefits form having one.

- All votes were unanimous in favor of adopting the plan
- The 2023 work plan was shared with the group via screen share by the facilitator.
- The work plan is a template used to direct our work and to apply for grants
  - KFSC is able to keep track of goals and which task were completed
- Highlight the strategies and what the KFSC wants to accomplish in 2024
  - o KFSC 4 basic strategies biggest project we do is the Forest Fair (bulk of strategy 3)
    - 1. Support agencies, comment on management actions and proposals

- 2. Cover the funding and be engaged with the boards needs
- 3.Kootenai Forest Fair
- 4. Conservation Goals work with Forest Service, common ground proposal, efforts from the legislative committee
- To receive grant funding, we need to summarize the outcomes "did the rubber hit the ground?"
- Discussion from the board on the 2024 Work Plan
  - "Coalition" to "Collaborative" change in our name can be taken off 1C to-do task because it has been accomplished
  - Treasurer Bob Casteneda was able to come up with some grant money and is in communication with Lincoln Fire Safe Council to get a fire adaptive workshop in Libby, to hammer home the things we need to do as a community (preparedness)
  - o Is the Collaborative all in favor of +181,000 acres of Wilderness?
    - The acre's number is going to change we are in the process of seeking feedback including the forest service agency
    - The proposal is a working progress, premature to discuss any changes or numbers
    - The number will change but the components of legislative proposal will change too.
    - Entire legislative package one part is legislative acres and is under review
      - Elements will change and number of acres is likely to change
    - Steve's chat comment "This is Steve with Zinke's office and if there are any grant applications that would benefit from a letter of grant support, please reach out to our office 406-422-8576"

# Recreation subcommittee agenda - Tony Petruscia

- Snowshoe trails project
  - -15 miles of trail ready to be worked on but waiting on lease agreement
  - Final plat agreement and link into Norgard trail that will connect with DNRC and will add 4 miles of trail for recreational bicycling
    - Swim pond plan moving forward, it will be a nice swimming Pond when things warm up
- Ripley trail project going forward gets us on sweet mountain bench
- How are we going to pay for Libby Recreation projects? A plan coming together through a
  foundation or sign-up and create endowment to take money from real estate sales and put into
  endowment and create an annuity out in the future.

### **Education and Outreach Subcommittee (Brooke) -**

- The date for the upcoming Forest Fair is September 21<sup>st</sup>
- If you want to join the committee for just the Forest Fair or the Outreach Committee overall let Brooke know
- Contact local groups to get more perspectives from all over different point-of-view
- Remember to occasionally be placing news stories and press releases into regional press

# **Legislative Update**

- Legislative Committee is in the process of reviewing the Common Ground Agreement
- Forest service has been asked to review the Agreement and make suggestions –
- Gratitude towards Zach for joining committee
- There is a standing committee meeting the 2<sup>nd</sup> Tuesday of every month

### **Budget**

- Our total proposed budget would be \$20,000 same amount as in work plan
- Financial report and proposed budget for 2024 Voting: unanimous approval of both

### **Update on OU3 Project**

- The project covers the area around the asbestos mine
- The firefighters have been concerned if there is a fire up there it could lead to asbestos contamination nearby
- District is proposing to treat the area around the mine site

- Do not have a firm proposal but working on that
  - District needs to develop exact acres and treatments and we will work with district to send letter to board on what we would like the forest service or district to do.
  - Coming up early in January

# **Update for Cabinet Ranger District**

- Cabinet district has an active project in the works Tusker project
  - o Similar to Saw Creek and dealing with forest health and fire reduction issues
- Ranger Michael Fieger is keenly interested in involving the public
  - Recruited neighbors to get involved
  - o Project includes vegetation and fuel management 2,700 acres
- Commercial and noncommercial harvest
- Implementation planned for 2024- scoping is open now and project docs are ready for comments in spring
- Goals include reduce stand density and increase species diversity
- Draft comment letter written, within a week comment letter can be revised by board members

### Additional Comments

- Trojan Defense project is proceeding as an authorized emergency action
- "As a Yaak resident Knotty Pine and Black Ram are very important to us. Please comment. We are under the highest fire risk in Lincoln County" (Bill Cripe)
  - We submitted comments in favor of Knotty Pine. We have not submitted comments on Black Ram (not an endorsement or non-endorsement).
- Ripley on legal front forest service is still moving forward and gathering information that Judge Christensen has asked for.
